Consulate General of India, Mandalay invites sealed bids to provide pest control services in premises of Consulate General of India, Mandalay and eight (8) residential house/apartments mentioned at Scope of Work.

- 6. The bidder or his authorized representative, who wish to be present, may attend the bid opening on the date and time specified.

A. GENERAL INSTRUCTIONS:

- 1. All the Tenders shall be prepared as per the prescribed format and submitted in accordance with instructions in the tender document.
- 2. All entries in the tender form should be legible and filed clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached.
- 3. Interested Parties may submit their sealed tenders after inspection of the premises. The inspection of the separate premises can be made with prior intimation till the last date for the receipt of tender.
- 4. Tenders will not be accepted after the time and date fixed for the receipt of tenders as set out in the Tender Notice or subsequent extensions.
- 5. All the prices should be inclusive of applicable taxes, if any with detailed breakup as per Form-II. Any correction or alteration is not allowed in the Financial Bid. The Lowest (L1) bidder will be decided on the basis of total price value quoted inclusive of applicable taxes, if any. The payments will be released to contractors after satisfactory completion of the work.
- 6. The submission of a tender by a tenderer implies that he had read this notice and the conditions of contract and has made himself/herself aware of the scope and specifications of work to be done and of the local conditions of the work.
- 7. The Consulate does not bind itself to accept the lowest or any tender or to give any reasons for not doing so.

(a) General Pest Control:

It means eradication of Cockroaches, Mosquitoes, Files, Lizards, Termite, Bugs etc. through the use of permitted insecticides as per WHO norms. The Pest control should cover all the places like space under the bed, sofa, table, chairs, almirahs, wooden furniture, false ceiling, staircases, lobby, all toilets drain ducts, kitchen, in stores and any hidden space under the furniture and no space should be left unattended.

(b) Rodent Control: Rat & Rodent inside the building:

- 1. The building is surrounded by the trees and plants and has open land area and therefore, rat ad rodent control is the main purpose of the tender. Rat/Rodent should by controlled by:
 - a) Catching Rats or reptiles,
 - b) Placing a glue mat or
 - c) Placing ultra sound devices as may be required in multiple numbers in all rooms
 - d) Doing permitted spray or putting herbal/chemical tablets etc. to keep rats and rodents away from building or force rats/rodents to move outside from buildings.
 - e) Combinations of any of the above.
- 2. It should be ensured that such chemicals should not be put so that rats/rodents/reptiles would die inside the building or above the false ceiling.
- 3. Agencies must ensure that the pest/rodent control once done shall remain effective up to next pest control, failing which it shall have to be done again and any cost therefor will not be entertained.
- 4. The pesticides, etc. used pest/rodent control should not create adverse Impacts on human health.

C. VALIDITY OF THE CONTRACT:

1. The period of contract will be for a period of one year from the date of signing of agreement between Consulate and successful bidder. However,

- the contract may be extended for a further period on mutual consent based on the performance assessment by Consulate General of India, Mandalay.
- 2. Consulate reserves the right to terminate the contract by giving 30 day's notice and without assigning any reason thereof.
- D. ELIGIBILITY CONDITIONS. As mentioned in Form-I (Technical Bid)
- **E. PAYMENT :** Payment to the vendor shall be released on monthly basis on submission of bills subject to the satisfaction of the officer concerned for services rendered in the particular month.
